TAG's Opening Remarks

EDS Marc Ferraro (Designee)

EDS Ferraro acted on behalf of TAG. He greeted the members and briefed them on the following:

- EDS told the members TAG is currently with the 193rd Special Ops and presenting them with the Governor's citation for their outstanding work they did with the long-term facilities and hospitals.
- EDS briefed on deployments: Approximately 1200 soldiers deployed with majority in Africa, 130 airmen deployed throughout the world and US. There are another 1500 soldiers and airmen preparing for deployment. There is a battalion getting ready to replace the current battalion in the Horn of Africa which will most likely be a yearlong deployment
- EDS stated there were many Memorial Day events at FTTG and other DMVA locations
- EDS informed the members TAG attended the PA Guard and Veterans Day event at the Capitol where 17 guardsmen were sworn in and 100-year-old WW2 Battle of the Bulge Veteran Ben Berry was honored for his service, as well as the PA National Guard for their critical performance at the Battle of the Bulge. He also said there will be a Battle of the Bulge event in December 2024 at FTIG.

Approval of the April 5, 2024, Meeting Minutes

Motion: Mr. David Gyger, VFW, made a motion to approve the minutes.

The body agreed; motion carried. Minutes approved with Chairman Taylor's request for the April 5, 2024 minutes, requested corrections were made.

Reading of Official and Other Communications

Chairman Taylor informed the members that he had sent a letter to Mr. Richard Fine the listed Commander of the PA Jewish War Veterans organization, enquiring on his health and status with the JWV. Also to draw Mr. Fine's attention that the JWV have not attended a SVC meeting in quite some time, and to ascertain how they would like to proceed with their SVC membership; as well as inform him he can assign a designee. The Chairman said he will follow up with a telephone call.

Deputy Adjutant General-OVA

DAG-OVA briefed members on the following:

- DAG-OVA told the members that Executive Director of BVH Mr. Travis Davis will not be briefing today due to being on vacation, and she will do a short brief on his behalf.
- BVH census is now over 1100, the highest in the last three years.
- The BVH homes will be hosting a lot of activities, and she encouraged the members to visit the homes and participate in the activities.
- She informed the members she will send out a draft agenda for the VETCon very soon.

DMVA Policy, Planning, and Legislation

Mr. Durand and Mr. Benge briefed members on the following:

- Mr. Durand briefed on the slides that were provided to the members in the read ahead they were sent, which is also posted on the SVC website.
- Mr. Durand did say that SB126 is on its way to being passed, it must have the house concur on the rules change/amend then to the Senate for a vote and to the Governor for his signature; everyone is certain it will pass. The passage process was addressed and clarified in the question section by Mr. Nate Silcox-Senate-VAEP after Mr. Hudzinski asked for clarification.
- Mr. Silcox also informed the members of bill 1160 which will make a designate day Vietnam Veterans Day, and bill 1192 allowing the DMVA to lease land and use monies for the Military Family Fund.

This bill eliminates veterans' compensation from being counted as income for the Real Estate Tax Exemption Program.

- Mr. Durand encouraged the members to spread the word about the two MAL openings for the SVC and advise for them to apply.
- In closing Mr. Durand addressed the appointments-MAL and to the home's councils. Those dates are set for service. If a qualified person is appointed after the start of the begin date, they still only serve until the end date. If no person is appointed qualified after the end date that member will be able to continue to serve until replaced.

Mr. Baylis-MAL asked if bill 126 includes the elimination of military retirements/pensions. It appears it only covers veteran disability compensation.

Mr. Johnson asked if a bill will be passed soon providing increased funding for the PA Blind/Paralyzed Pension, and if so which amount-three were proposed. He was told those bills are tied up in budget negotiations.

Mr. Baylis asked what the procedure would be for a veteran organization to join the SVC- he cited the Navy Club. Mr. Durand explained the veteran organization would have to have a state representative formulate a bill to place that particular veteran organization on the SVC which would then have to be voted on passed, and signed into law by the Governor.

DMVA Bureau of Homes

DAG-OVA covered that on behalf of Mr. Davis (see above).

DMVA Bureau of PIRO

Mr. Mutschler briefed on the following:

- Informed members of DMVA-OVA PIRO guiding principal of working together in a collective focus to enhance the well-being of veterans within communities as a collaborating effort together-One Team.
- Mr. Mutschler stressed the importance of cross training with all partners, he cited the cross training with TAL and VFW and focusing on rural areas, such as western PA, to reach those veterans and how effective it is, and how it improves the delivery of services both federal and state.
- VETConnect has a network of over 2000 resources. Held over 300 events and had over 6000 interactions with veterans. They had many personal interactions with veterans helping with home repairs as well as critical interventions with veterans experiencing personal difficulties.
- VETConnect is engaging with corporations to provide a review of benefits to their employees by our VSOs. The most recent was at the request of Bank of America.
- Working with AARP and the PA OAG to ensure veterans are not taken advantage with their benefits.
- Working with the Governor Shapiro on the suicide prevention challenge to prevent suicide in families. Mr. Rick Hamp is the lead on this program and he his working with the research at the University of Pittsburgh and Department of Health, as well as the PA National Guard.
- Mr. Mutschler noted the growing number of tiny veteran housing villages in the greater Harrisburg area which also includes combining benefits.
- He drew the members attention to the read ahead slides in the growing increases the RETX, Educational Gratuity, Blind and Paralyzed Pension programs.

Mr. Johnson asked if there was any deceive movement on the monetary increase with the Blind/Paralyzed Pension. Mr. Mutschler said there are three bills with different increase amounts but currently are in the negotiation stage at the Capitol.

Mr. Beiler directed the members to his materials in the read ahead slides and talking points. He briefly highlighted some information:

- He noted VISN 4 is consistently trending up in trust/deliverable services throughout the network.
- VA creating a "compelling circumstances exception for certain former service members "willful and persistent misconduct". VA will review the compelling circumstances underlying the discharge
- Update on "moon-shot" cancer program- brought services to over 9000 veterans in 30 locations by the end of 2025, increased cancer care in rural areas as well.
- There has been a 20% increase in providing healthcare to veterans.
- Increased homelessness care and placements.

Questions/Discussions

Question 1: Rich Hudinski brought up the fact that some SSVF vendors don't provide transportation to Veterans when trying to find housing for them and this creates a barrier for Veterans with transportation issues. Sounded like there may have been a change in SSVF vendors in the WB area and the previous vendor would provide transportation to go look at housing with the Veteran but the new vendor does not offer that?

Response from VISN 4: Services provided by an SSVF grantee are submitted in an application by the grantee through the Notice of Fund Availability (NOFA) process: A NOFA is published in the Federal Register in accordance with 38 CFR 62.40, which announces the availability of funds for supportive services grants. Several services are mandated by statute or the NOFO such as case management, connection to VA services and benefits, and legal services. Transportation services are not mandated, but can be offered in a variety of ways, based on locations and resources, and SSVF grantees are encouraged to use or share community and public resources when possible.

"1h. Connections to Transportation Options for Grantee:

1: Direct; 2. Indirect; 3 Both SSVF participants should be supported to connect with transportation on an asneeded basis, for housing stability purposes when the Veteran lacks access to a car or public transportation. Where available, grantees should help participants take advantage of subsidized transportation and free bus passes in their jurisdiction. These are typically offered for low income people who have disabilities or are elderly. Participants should also be connected to local shuttle services to VA Medical Centers, shuttles that typically leave from Veteran service organization sites. To supplement local transportation assistance, grantees have the option to provide transportation to participants themselves to transport participants to service appointments, including health appointments, and housing search- related destinations. When transportation is provided, grantees must devise a written policy requiring that all drivers have a valid driver's license, cell phone access inside the vehicle, and training on agency transportation procedures. Such policies also must call for insurance for all vehicles used to transport participants. Note, in addition to the resource access approach outlined here, transportation may also be paid for directly by SSVF temporary financial assistance. When transportation is needed, the grantee can use ride sharing companies (Uber, Lyft, etc). In order to justify the need, grantees must provide documentation of the purpose and show that traditional public options are not available."

"2g. Transportation Assistance

A grantee may provide transportation assistance if it will enhance housing stability. For example, a participant may require assistance with transportation to a job interview or a medical appointment. Because the use of public transportation is generally less expensive than the use of private vehicles and may be more sustainable in the long-term, grantees should consider providing public transportation tokens or vouchers before offering financial assistance for personal vehicles. If sufficient public transportation options are not locally available, a grantee may provide car repair or maintenance assistance on behalf of a 2g. Transportation Assistance A grantee may provide transportation assistance if it will enhance housing stability. For example, a participant may require assistance with transportation to a job interview or a

medical appointment. Because the use of public transportation is generally less expensive than the use of private vehicles and may be more sustainable in the long-term, grantees should consider providing public transportation tokens or vouchers before offering financial assistance for personal vehicles. If sufficient public transportation options are not locally available, a grantee may provide car repair or maintenance assistance on behalf of a participant. " (car repair is an option under GHSA which has a cap – again should talk to their case manager)

Question 2: From Mark Baylis: My question to Mr. Leizert's stand in was in regard to homeless Veterans finding housing. A previous organization receiving grants from Dept of VA to provide homeless Veteran housing assistance money had a staff person to be the liaison with landlords and take transportation challenged Veterans to see apartments. The new VA grant recipients don't have a staff person for that function. I asked him if they could add the requirement to provide that service (housing locator / transport person) to the grant requirements for this year's applicants to be SSVF / HUDVASH providers.

Response from VISN 4: -Case Management is one of the mandated services:

Role of Case Manager in Coordinating Provision of Supportive Services:

An effective case manager should be familiar with the area or community in which the program operates and actively cultivate a working knowledge and connections to relevant area resources such as affordable housing providers; emergency, medical and other care professionals; public benefits offices; employment training and job placement programs; affordable daycare; legal or credit counseling services; transportation, etc."

Should the Veteran have concerns with their case manager, or the SSVF agency not providing necessary services, it is encouraged that the Veteran first talk to the appropriate person at that agency to inquire further about their individualized plan. This will help the Veteran with self-advocacy as well as helping to develop out another goal, or modify an existing goal, in the Veterans permanent housing stability plan which may include referral to community resources or exploring housing options where the Veteran has more access to transportation. The Veteran can also speak with a VA Liaison (case manager, peer support, etc.) to which they can address any issues identified by the Veteran.

Presentation: Women Veterans Museum

- Ms. Williams and other women veterans after experiencing a public understanding of the major roles women play in the military-past, present and will in the future decided to educate by forming a museum dedicated to women in the military.

- The museum unexpected had visitors that were allied Korean War Veterans seeking assistance. Ms. Williams then moved the museum to begin doing research, finding resources and networking with the VA to assist. She mentioned how grateful she is to now be connected to the PA DMVA.
- She said she went back to school to get her master's in therapy to treat veterans in her area that are recently released from the prison in the area that are addicted to drugs/alcohol.



We build relationships that amplify service to the SMVF community

- <u>Region 1</u> VSS meet an affordable housing organization out of Butler County that houses Veterans. She was asked to come and speak to a Veteran who was struggling to get personal care and VA assistance. VSS met with the Veteran and got him directed to the VHA where he is now enrolled and assigned a case worker to get services in his home set up. VSS also reached out to RPOC to see if there was an organization that could provide household goods that the Veteran needed. RPOC reached out to Veterans Miracle Center who will be donating items for the Veteran.
- <u>Region 2</u> The Pitt FO VSO encountered a WV veteran while doing outreach who was staying at VAPHS CLC for rehab. The veteran has since been released back to her home in WV but currently has no income. The RPOC reached out to the VOP from the Wheeling, WV Vet Center who was then a ble to provide three resources for financial assistance to the veteran while she is awaiting her VBA claim to be adjudicated.
- <u>Region 3</u> VSS attended the equine therapy program at Stars and Stripes in Adams County and was a ble to interact with 5 veterans including a Vietnam Veteran whose condition is worsening. She was able to educate him on presumptive related to AO and referred him to the CDVA office. Also spoke with several women veterans educating them on benefits and women veterans programming.
- <u>Region 4</u> Valhalla Veteran Services had an emergency last week with a shortage of volunteers RPOC connected with a combat veteran group that meets with the Scranton Vet Center, which resulted in 4 new volunteers to assist as needed back up to assist at the facility for the military share program.
- <u>Region 5</u> VSS helped the surviving Mother of a Veteran who died of suicide get grants from the Cannoneers Club and the Travis Manion Foundation to defray the costs of burial. I also had her contact the VA to report his death, terminate his Disability Compensation, and apply for Burial Benefits.




Amputee & Paralyzed Veterans' Pension



Blind Veterans' Pension












Veterans' Temporary Assistance









Improvements to the Access to Care website

Average wait times for all VHA medical centers and clinics are now calculated to include additional steps in the appointment process that had not been captured in the past.

- For **<u>new patient</u>** appointments, average wait time is calculated from the earliest time a request for care is consistently recorded in the scheduling system to the date the appointment is completed or the date it is scheduled to occur if not yet completed.
- For **established patient** appointments, average wait times are measured from the date agreed upon between a Veteran and provider for future care and ends on the date care is received, or the date that care is scheduled to occur if it has not yet occurred.

The upgraded calculation makes the website more reflective of the complete process of requesting and receiving care. Averages are representative of general performance and may not represent individual experience. Average wait times are never used to determine eligibility for community care.



Patient Experience Update- Trust

VISN 4 has consistently received the highest trust score in the nation at 94.7% and continues to trend up. Our network also has the highest number of compliments at 78.6% and the lowest number of concerns at 10.8%. The top 5 compliments recently are interactions with staff, cleanliness of facility, quality of care, satisfaction with specialty care, and courtesy of healthcare providers.

Connected Care Update

<u>New MHV Sign-In Transition Process</u>: In 2025, Veterans will need to start using either Login.gov or ID.me to sign-in to VA websites or apps, including My Health*e*Vet. The VA is moving to a more modern experience with these two secure sign-in account options (Login.gov and ID.me).

- Login.gov is <u>our government's one account provider</u> for VA and other government benefits and services. The U.S. General Services Administration creates and maintains this account.
- ID.me is <u>a non-government account provider</u> that contracts with government and non-government organizations. ID.me creates and maintains this account.

This transition helps to meet Veterans' requests for a simpler sign-in experience while continuing to improve security standards, comply with federal policies, and ensure Veteran data and identity protection. Therefore, after January 31, 2025, Veterans will not be able to sign-in to VA websites or apps with a My Health*e*Vet user ID and password. After September 30, 2025, Veterans will not be able to sign-in with a DS Logon username and password.

We encourage Veterans to create a Login.gov or ID.me account now. If Veterans already have one of these accounts but have not yet used it, they are encouraged to start now so they have time to get used to it before the upcoming change. With Login.gov or ID.me, Veterans will have access to all the same information and services they use today.

<u>Annie Registration</u>: Annie is VAs messaging service that empowers Veterans to take an active role in their care. Text messages received from Annie can include reminders to take medication, tips for reducing stress, instructions to prepare for an upcoming appointment, and more. Once Veterans are registered for Annie and have chosen a health subscription, they will begin to receive automated text messages. Annie requires an online registration followed by the option to interact with Annie via text message, online, or both. To use Annie, Veterans must have a Login.gov, ID.me, My Health*e*Vet Premium Account credential (until January 31, 2025), or DS Logon credential (until September 30, 2025).

Once registered for Annie, a Veteran can subscribe to receive text messages about specific health interests. There are many health subscriptions to choose. If one is of interest, a Veterans will text SUB, followed by the health subscription's keyword to Annie (75338). For example, to subscribe to the Annie medication reminder health subscription (MED), a Veteran will text SUB MED. More information about Annie can be found at the VA Mobile App Store.

<u>VA Health and Benefits App</u>: Veterans can manage their VA health care, benefits, and payments from their mobile phone. With the VA Health and Benefits app, Veterans can access the information below. Get started today by downloading the app via the Apple App Store or the Google Play Store.

HRO Highlight- Altoona VAMC

One of VHA's seven HRO values is "Support a Culture of Safety", which was demonstrated to a Veteran recently by the collaborative efforts of the VISN 4 Clinical Contact Center (CCC) and the Altoona James E. Van Zandt VA Medical Center (Altoona VAMC).

In the early morning of March 12, 2024, a 49-year-old 100% service-connected male Veteran called the VISN 4 CCC. The call originated from an adjacent hotel to the

Altoona VAMC, during which the Veteran self-reported having a weapon in his possession and fearing coming out of his hotel room, sharing thoughts of a hitman waiting outside the hotel room door. The Veteran was requesting a VA Police escort to the Altoona VAMC to seek care.

VA Police Lieutenant Melanie Rininger was briefed by VA Police Senior Officer Douglas Smalley and VA Police Dispatcher Ashley Nevling, all from the Altoona VAMC, of the situation and began to collect intel while also conducting a Random Anti-terrorism Measure (RAM) to ensure safety around the main entrance at Central Registration of Altoona VAMC. Once complete, Lieutenant Rininger directly called the Veteran's personal cell phone. He answered, stating he was on the phone currently with an "ANDREA" from the VA Crisis Line, but requested to stay on the line with Lieutenant Rininger because he trusted VA Police. While trying to connect back to the VA Crisis Line for a three-way conversation the call dropped with the VA Crisis Line and only VA Police (Lieutenant Rininger) remained on the line. Lieutenant Rininger offered to have VA Crisis Line recontacted to return on the line, but the Veteran declined. During the three (3) hour conversation with Lieutenant Rininger, VA Police Captain Warren Edward and VA Police Deputy Chief Brandon Lape joined at precise moments to negotiate with the Veteran and to comply with local Altoona Police Department who were outside of the hotel door.

The conversation between the Veteran and VA Police during the duration of this call included gaining the trust of the Veteran, respecting the Veteran and honoring his service, relating to the Veteran with military experience to deescalate the situation, and using procedures to help the Veteran feel he was safe to lay prone on the floor and comply with local police commands. Local police were able to access the hotel room, secure the Veteran safely, and transport him to a local Altoona hospital for care. The interventions of our VA Police made a deep impact and saved this Veteran's life during a critical moment. Their invaluable service proved that they are true heroes and embrace the ICARE values. Their efforts, dedication, teamwork, communication, and critical thinking avoided a worst-case scenario that could have escalated quickly. All HRO principles were put into action during this situation - Sensitivity to Operations and Reluctance to Simplify were present throughout the entirety; Preoccupation with Failure and Deference to Expertise were present as every staff member involved became a problem solver and deferred to experts in other departments to handle certain aspects of the situation; the officer's Commitment to Resilience was also present when the call was dropped by Crisis Support, maintaining contact with the Veteran and rectifying the situation. We are incredibly proud of this team and what they were able to do to help save the life of this Veteran!

Preventing Suicide among Veterans

VA marked the <u>two-year anniversary of the 988 Suicide and Crisis lifeline</u> on July 16, 2024. Since the 988, press 1 launch CL has answered more than 1,638,138 calls,

representing a 22.7% increase in calls per day since the launch. This means that more Veterans than ever are getting the support they need from caring, qualified responders during times of crisis.

There were 1,002,725 contacts in FY23 (calls, chats, and texts). In FY 24, from October 1, 2023, to May 31, 2024, there were 722,418 contacts (calls, chats, and texts).

There was a total of 77,730 calls, 11,518 chats and 7,201 texts received for a grand total of 96,449 contacts in May 2024.

New Cooperative Agreements

On June 24, 2024, <u>VA announced \$10 million in new funding</u> for eligible states, territories, and Tribal governments through cooperative agreements to better inform Veteran suicide prevention strategies.

These cooperative agreements will provide funding and technical assistance intended to establish, coordinate, and manage suicide mortality review committees, which identify and characterize suicide deaths.

Suicide mortality review committees help establish a local understanding of suicide, identify populations or locations of special concern, and inform the development and implementation of data-informed suicide prevention strategies for Veterans.

This funding opportunity advances VA's National Strategy for Preventing Veteran Suicide, the Biden-Harris administration's strategy to reduce military and Veteran suicide, and President Biden's Unity Agenda for the nation.

PACT Act Update

On May 21, 2024, <u>VA granted it's 1 millionth PACT Act-related disability compensation</u> <u>claim</u> to Veterans and survivors since President Biden signed the bill into law on Aug. 10, 2022.

Ending Homelessness among Veterans

VA has taken aggressive action to combat Veteran homelessness. In calendar year 2023 <u>VA permanently housed 46,552 homeless Veterans, exceeding its goal to house 38,000</u> by 22.5%.

On July 1, 2024, VA announced it is awarding \$26.8 million in legal services grants to a total of 108 public and non-profit organizations, all with the goal of increasing access to legal services for eligible Veterans experiencing or at risk for homelessness.

This grant program is enabled by the Johnny Isakson and David P. Roe, M.D., Veterans Health Care and Benefits Improvement Act of 2020 and ensures at least 10% of funding supports the provision of legal services for women Veterans. Individual grant awards are up to \$300,000 for a 14-month grant cycle starting Aug. 1, 2024. Grant recipients will deliver a variety of legal services to Veterans.

<u>VA announced its 2024 goals</u> in support of its efforts to prevent and end Veteran homelessness on March 14, 2024.

Specifically, in fiscal year 2024, VA will:

Place at least 41,000 Veterans experiencing homelessness into permanent housing.

Ensure that at least 95% of the Veterans housed in FY 2024 do not return to homelessness during the year.

Engage with at least 40,000 unsheltered Veterans to help them obtain housing and other wraparound services.

As of June 30, 2024:

34,764 Veterans have been permanently housed, representing 84.8% of the goal. VA is currently on track to meet this goal but is monitoring it closely to ensure that homeless Veterans are connected to the housing resources they need.

97.0% of the Veterans housed so far have remained in housing. 1,039 Veterans have returned to homelessness, representing 3.0% of the Veterans housed. VA is monitoring this goal closely to ensure that Veterans stay housed or are re-engaged by VA services if they return to homelessness.

31,294 unsheltered Veterans have been engaged, representing 78.2% of the goal. VA is currently on track to meet this goal but is monitoring it closely to ensure that unsheltered homeless Veterans are connected to the housing resources they need.



ACCOUNTING FOR OUR MISSING PERSONNEL

The Defense POW/MIA Accounting Agency's mission is to provide the fullest possible accounting for our missing personnel from past conflicts to their families and the nation. Within this mission, we search for missing personnel from World War II (WWII), the Korean War, the Vietnam War, the Cold War, the Gulf Wars, and other recent conflicts. Our research and operational missions include coordination with hundreds of countries and municipalities around the world.

At present, more than 81,500 Americans remain missing from WWII, the Korean War, the Vietnam War, the Cold War, and the Gulf Wars/other conflicts. Out of the more than 81,500 missing, 75% of the losses are located in the Indo-Pacific, and over 41,000 of the missing are presumed lost at sea (i.e. ship losses, known aircraft water losses, etc.).



*Casualty numbers are related to only those associated to our mission starting from 1973 to present and don't reflect the total number of missing from each conflict.

**To respect the next-of-kin, individuals are only displayed as "Accounted For" in the grids and case profiles when (1) DPAA has made the identification, and (2) the next-of-kin has been notified.

Numbers that are not associated with individual names will continue to update as soon as an identification has been made.
